#### Potential Health Effects

##### Inhalation:

Mild acidic irritant. Can cause coughing, sneezing, possible breathing difficulty.

**Ingestion:**

Toxicity information is limited but piperazine and its derivatives are usually only slightly to moderately hazardous. Normal precautions for handling organic compounds with undefined properties should nevertheless be observed and the appearance of any of the usual symptoms of poisoning (abdominal pain, nausea, vomiting, diarrhea) acted upon promptly.

Possibly a mild irritant causing local inflammation and soreness, especially on prolonged contact with sensitive areas.

#### V. FIRE FIGHTING MEASURES

## VI. ACCIDENTAL RELEASE MEASURES

### **Ventilation System:**
